APPLICATION FOR ORDER TO SHOW CAUSE
REGARDING PRO SE PLAINTIFFS

Defendants Janssen, L.P.¹ and Johnson & Johnson (hereafter "Defendants") request that this Court issue an Order to Show Cause Regarding Pro Se Plaintiffs² why their respective actions should not be dismissed with prejudice³ if they fail to take one of the following two actions within sixty days from date the requested order is entered:

- (1) Notify the Special Master at **Special Master's Office, 400 Poydras Street, Suite 2820, New Orleans, LA, 70103; (504) 586-7995 (phone); (504) 586-1998 (fax)** that they intend to enroll in the MDL Resolution Program (hereafter the "Program") by completing the Notice of Election Form (attached hereto as Exhibit A) and mailing it as directed on the form. Pro Se Plaintiffs who choose to enroll in the Program must comply with the provisions of the MDL Term Sheet and serve their



- (2) Notify the Special Master at **Special Master's Office, 400 Poydras Street, Suite 2820, New Orleans, LA, 70103; (504) 586-7995 (phone); (504) 586-1998 (fax)** that they intend to pursue their case, pro se or with new counsel, rather than enroll in the Program, by completing the Notice of Election Form (attached hereto as Exhibit A) and mailing it as directed on the form within 60 days from the date of entry of the Order to Show Cause. Pro Se Plaintiffs who choose this option must then respond to Interrogatories (attached hereto as Exhibit B) pursuant to the Federal Rules of Civil Procedure and provide an appropriately executed Medical Authorization Form (personal injury claimants should complete Exhibit C and wrongful death claimants should complete Exhibit D) to Defendants within 30 days from the date the Notice of Election Form is signed.

The Court has assigned Robert Johnston, Law Office of Robert M. Johnston, L.L.C., Pan American Life Center, 601 Poydras Street, Suite 2490, New Orleans, LA 70130, (504) 561-7799, as Curator to assist the Pro Se Plaintiffs in making decisions regarding their options, at no cost to the Pro Se Plaintiffs. Upon entry of the Order to Show Cause Regarding Pro Se Plaintiffs (the Proposed Order is attached as Exhibit F), Defendants shall serve a copy of such Order on all the Pro Se Plaintiffs for whom they have addresses or other contact information. As to those Pro Se Plaintiffs for whom

Defendants have no address or other contact information, Defendants shall publish the Order to Show Cause Regarding Pro Se Plaintiffs on the Court's website at "<http://propulsid.laed.uscourts.gov/forms.htm>". (See Affidavit of Tracie Militano, attached as Exhibit G). Publication of the Order to Show Cause Regarding Pro Se Plaintiffs will take place on the day of entry of the Order to Show Cause. Pro Se Plaintiffs who fail to take one of the two above-described actions, within the required sixty days from the service or publication of the Order, are ordered to appear before this Court at 9:00 a.m. on November __, 2006 in Courtroom C-456, U.S. Federal Building, 500 Poydras Street, New Orleans, Louisiana 70130, to show cause why their cases should not be dismissed with prejudice. Pro Se Plaintiffs who fail to serve their Notice of Election From and Enrollment Form within the sixty days will have their actions dismissed with prejudice. Pro se Plaintiffs who elect to pursue their cases, pro se or with new counsel, but fail to respond to Interrogatories (Exhibit B) and/or provide medical authorizations (Exhibits C and D) within 30 days after submitting their Notice of Election shall have their actions dismissed with prejudice.





THIS IS AN IMPORTANT COURT ORDER.

PLEASE READ IT CAREFULLY.

You¹ have filed a lawsuit regarding the drug Propulsid against defendants Janssen, L.P.² and Johnson & Johnson (“Defendants”). Your lawsuit has been joined with many similar lawsuits in a legal proceeding before this Court.

This Order tells you what you must do if you want to proceed with your Propulsid lawsuit. If you choose to pursue your case further, you must do one of two things. If you do not do so, your lawsuit will be dismissed with prejudice and neither you nor someone on your behalf will be permitted to file another Propulsid lawsuit. “Dismissal with

- (1) Notify the Special Master at **Special Master’s Office, 400 Poydras Street, Suite 2820, New Orleans, LA, 70103; (504) 586-7995 (phone); (504) 586-1998 (fax)** that you intend to enroll in the MDL Resolution Program (hereafter the “Program”) by completing the Notice of Election Form (attached hereto as Exhibit A) and mailing it as directed on the form. If you choose to enroll in the Program you must comply with the provisions of the MDL Term Sheet and serve your Enrollment Form and the Notice of Election Form within sixty days from entry of this Order to Show Cause. OR

- (2) Notify the Special Master at **Special Master’s Office, 400 Poydras Street, Suite 2820, New Orleans, LA, 70103; (504) 586-7995 (phone); (504) 586-1998 (fax)** that you intend to pursue your case, pro se or with new counsel, rather than enroll in the Program, by completing the Notice of Election Form (attached hereto as Exhibit A) and mailing it as directed on the form within 60 days from the date of entry of this Order to Show Cause. If you choose this option you must then respond to Interrogatories (attached hereto as Exhibit B) pursuant to the Federal

Rules of Civil Procedure and provide an appropriately executed Medical Authorization Form (personal injury claimants should complete Exhibit C and wrongful death claimants should complete Exhibit D) to Defendants within 30 days from the date the Notice of Election Form is signed.

This Application addresses those *pro se* plaintiffs who are in the MDL and are *currently*: (1) *not represented* by counsel, and (2) *not enrolled* in the Program. A complete list of these plaintiffs (hereafter the "Pro Se Plaintiffs") is attached as Exhibit E.

IF YOU DO NOT CHOOSE ONE OF THESE OPTIONS WITHIN THE 60 DAY PERIOD, YOUR PROPULSID LAWSUIT WILL BE DISMISSED WITH PREJUDICE AND NEITHER YOU NOR ANYBODY ACTING ON YOUR BEHALF WILL BE PERMITTED TO FILE ANOTHER PROPULSID LAWSUIT, UNLESS YOU SHOW THE COURT GOOD CAUSE BY APPEARING BEFORE THIS COURT, at 9:00 a.m. on November __, 2006 in Courtroom C-456, U.S. Federal Building, 500 Poydras Street, New Orleans, Louisiana 70130.

UPON ENTRY OF THE ORDER TO SHOW CAUSE, DEFENDANTS SHALL SERVE A COPY OF THIS ORDER ON ALL PRO SE PLAINTIFFS FOR WHOM THEY HAVE ADDRESSES OR OTHER CONTACT INFORMATION. AS TO THOSE PRO SE PLAINTIFFS FOR WHOM THERE IS NO ADDRESS OR OTHER CONTACT INFORMATION, DEFENDANTS SHALL PUBLISH THIS ORDER (A) INFORMING THEM TO VISIT THE COURT WEBSITE OR CONTACT THE CURATOR TO OBTAIN IMPORTANT INFORMATION REGARDING THEIR PROPULSID LAWSUITS³, AND (B) WARNING THEM THAT IF THEY DO NOT

at least one telephone call to the responsible paralegal or attorney who previously represented these pro se plaintiffs to obtain this contact information.


